

## SULPHUR PARKS AND RECREATION (SPAR) Regular Board of Commissioners Meeting Held at the SPAR Recreation and Aquatic Center Multipurpose Room 933 W. Parish Road Sulphur, LA 70663 Tuesday, February 20, 2024, 5:30 pm

The Board of Commissioners of Sulphur Parks and Recreation (SPAR) met at 5:30 pm on Tuesday, February 20, 2024 in the multipurpose room at SPAR Recreation & Aquatic Center in Sulphur, Louisiana for a regular scheduled board meeting. The meeting was called to order and a roll call was taken. Board members present were Don Martin, David Devall, Mike Boyette, and David Couvillon. Len Lemelle was absent.

The minutes of the January 16, 2024, regular board meeting were approved as presented on a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried.

The director, Ms. Laurie Koelzer, presented the December 2023 financials (*Prior to year-end audit adjusting entries*) with all expenses and revenues as expected and within budget. On a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried, the December 2023 financials were adopted as presented.

The board was notified that January 2024 financial statements would be presented at the March 2024 board meeting, providing staff additional time to convert to the new accounting system. No action was taken.

The board, on a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried, approved the terms of engagement agreement, including the statewide agreed-upon-procedures, for professional service(s) provided for the financial audit of FYE 2023 to be conducted by Gragson, Casiday, and Guillory, LLP. (Board approved resolution at the Dec. 19, 2023, regular board meeting to adopt Gragson, Casiday, and Guillory, Certified Public Accountants as Auditor for SPAR for year ending 12/31/2023)

The board resumed discussion of the tabled item to consider awarding the low public bid received and opened on January 11, 2024, to cover the Batting Cage located at the Quad at McMurry Park from Angelico Construction in the amount of \$93,950. Board tabled the item at the January 2024 regular meeting pending staff research of cost savings available, as requested by the board. Value engineer savings and public bids received as outlined below. The board, on a motion by Mr. Couvillon, seconded by Mr. Martin, and carried, rejected all bids.

## Value engineering savings available:

Option A – Removing side walls = Deduct \$10,200 Revised Bid = \$83,750 Option B – Remove side walls and Change roof to 26g R-Panel = Deduct \$15,500 Revised Bid = \$78,450 Other deductions available: Remove roof insulation = Deduct \$1500 Concrete foundations for column bases only = Deduct \$1000 Possible deduction if water meter doesn't need to be moved = Deduct \$2700

Following rejection of all bids, no board action was taken on staff request for permission for the Director to issue and execute change orders as necessary not to exceed 10% greater than the contract amount following consideration of value engineer savings of the public bid received and awarded to Angelico Construction by the Board at this meeting for the Batting Cage Cover located at the Quad at McMurry Park.

On a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried, the board granted permission for the Director to issue and execute change orders as necessary not to exceed 10% greater (\$37,500) than the low public bid in the amount of \$375,000 received and awarded to Sabine Pools, LLC on Feb. 1, 2024, by board authority granted at the Jan. 18, 2024, regular board meeting.

• Notification of the staff's acceptance of the low public bid of \$375,000 was received from Sabine Pools, LLC for the resurfacing and repairs on the original portion of the Waterpark pools. Work to begin late February 2024 with completion 90 days from notice to proceed (early May 2024). (The board granted permission for Director to accept and award to lowest bidder at the Jan. 18, 2024, regular board meeting. Architect projected cost estimate of \$550k).

Following presentation and discussion, the board adopted the 2024 waterpark season calendar to include residents only through the month of May and preserve the resident ONLY Friday, policy change to prohibit re-entry, facility rental fees, and established 2024 season rates by maintaining in-district rates as set in 2023 and increasing out-of-district rates to \$20 per visitor on a motion by Mr. Couvillon, seconded by Mr. Boyette, and carried.
